Title Goodness-of-Fit Measures for Categorical Response Models

Version 0.1.2

Description A post-estimation method for categorical response models (CRM). Inputs from objects of class `serp()`, `clm()`, `polr()`, `multinom()`, `mlogit()`, `vglm()` and `glm()` are currently supported. Available tests include the Hosmer-Lemeshow tests for the binary, multinomial and ordinal logistic regression; the Lipsitz and the Pulkstenis-Robinson tests for the ordinal models. The proportional odds, adjacent-category, and constrained continuation-ratio models are particularly supported at ordinal level. Tests for the proportional odds assumptions in ordinal models are also possible with the Brant and the Likelihood-Ratio tests. Moreover, several summary measures of predictive strength (Pseudo R-squared), and some useful error metrics, including, the brier score, misclassification rate and logloss are also available for the binary, multinomial and ordinal models. Description

Provides the means of testing the parallel regression assumption in the ordinal regression models. Also available is the likelihood ratio test, LR.test().

Usage

Details

The parallel regression assumption for the ordinal regression model can be tested With this function. The brant test (Brant, 1990) is currently available for objects of class: `serp()`, `clm()`, `polr()` and `vglm()`. Objects of class `serp()` should have the `slope` argument set to 'parallel', while objects of class `vglm()` should have the `model` argument TRUE, if not, the model is automatically updated to include the object 'model'. Moreover, family in `vglm()` must be either "cumulative" or "propodds", with the parallel argument TRUE.

Hosmer-Lemeshow Test for Categorical Response Models

Description

This is a post estimation goodness-of-fit test for categorical response models. It currently supports the binary, multinomial and ordinal logistic regression models.

Usage

group	Default to 10. The number of groups to be formed from the original observations.
tables	Default to FALSE. When TRUE, both the observed and the expected frequency tables are printed alongside test results.
customFreq	a vector of custom group frequencies to be used instead of the default equal group frequencies. The vector should, however, sum up to the total number of original observations.

Details

The implemented tests are discussed in Hosmer and Lemeshow (1980) (for the binary case), Fagerland, Hosmer, and Bofin (2008); Fagerland and Hosmer (2012) (for the multinomial case) and Fagerland and Hosmer (2013, 2016, 2017) (for the ordinal case). In each of the three settings, one makes a split of the original observations into k groups (10 by default), after ranking the observations by ordinal scores (OS). Ties are separated following an additional ranking based on the observed values. A Pearson chi-squared statistic is thereafter obtained from a $(k \times c)$ expected and observed frequency tables. The `Hosmerlem()` function automatically dictates which of the three HL tests to run based on the type of model supplied or by inspecting the class/level of response category in the supplied data.frame of predicted and observed values.

On the choice of k -groups, Fagerland and Hosmer (2013, 2016) recommend using ten groups. It is believed that number of groups below six adversely affects the heterogeneity within groups thereby resulting in a test with low power. Also having too many groups could lead to a sparsely populated contingency tables, affecting the distributional assumptions of the test statistic. The test statistic follows the chi-squared distribution with $(k - 2)(r - 1) + (r - 2)$ degrees of freedom. Where k and r are respectively the number of groups and response category. For chi-square estimation to hold, it is recommended to have the percentage of estimated frequencies greater than 80 percent of all estimated frequencies (Fagerland and Hosmer, 2017).

Finally, it is particularly recommended to compare the results of the ordinal Hosmer-Lemeshow test with the lipsitz and the Pulkstenis-Robinson tests (Fagerland and Hosmer, 2016; 2017).

Description

This provides a post estimation goodness-of-fit test for the ordinal response models. Supported models include the proportional odds, adjacent-category, and constrained continuation-ratio models.

Usage

Details

Similar to the ordinal Hosmer-Lemeshow test ([hosmerlem](#)), the Lipsitz test also group the observations into k separate groups using the ordinal scores of the estimated values. According to Lipsitz, Fitzmaurice, and Molenberghs (1996), the number of groups should be such that $6 \leq k < n/5r$, with r the number of response category. An indicator variable is used to denote the observations

belonging to each group, producing additional pseudo variables with which the original model is updated. Supposing the original model fits correctly, then the coefficients of the pseudo variables all equal zero. The likelihood ratio statistic calculated from the log likelihoods of the original and the refitted models is subsequently compared with the chi-squared distribution with $k - 1$ degrees of freedom.

The Lipsitz test compliments the ordinal Hosmer-Lemeshow and the Pulkstenis-Robinson tests. Fagerland and Hosmer (2013, 2016, 2017) recommend comparing the three test.

This provides a post estimation goodness-of-fit test for the ordinal response models. Supported models include the proportional odds, adjacent-category, and constrained continuation-ratio models.

Details

The Pulkstenis-Robinson test groups the observations using the covariate patterns obtained from the categorical covariates. Each covariate pattern is subsequently split in two based on the median ordinal scores. The test statistic (chi-sq or deviance) is obtained using the tabulated observed and estimated frequencies. Assuming c is the number of covariate patterns, r the number of response categories and k the number of categorical variables in the model, the test statistic approximates the chi-sq distribution with $(2c - 1)(r - 1) - k - 1$ degrees of freedom (Pulkstenis and Robinson (2004)). As recommended in Fagerland and Hosmer (2016, 2017), this test should be compared with the Hosmer-Lemeshow and the Lipsitz tests.

R-squared for Categorical Response Models

Description

computes the summary measures of predictive strength (i.e., pseudo-R2s) of several categorical outcome models.

Usage

Details

Rsquared provides different R2 indices for both binary and multi-categorical response models. Supported classes include: `glm`, `vglm`, `clm`, `polr`, `multinom`, `mlogit`, `serp`. In other words, mainly models with binary or multi-categorical outcomes are supported. The non-likelihood based measures, including the Mckelvey, Tjur and Efron R2s are only available for binary models, while the rest of the measures (likelihood-based) are all available for both binary and multi-categorical models. The Ugba & Gertheiss's R2 in particular, computes the recently proposed modification of the popular Mcfadden's R2. The likelihood ratio index in the said R2 is penalized using either a square-root or logarithmic stabilizing function of the response category. The two approaches yield practically the same result.

Value

measure	the name of the R-squared calculated.

adj	adjusted R2, only available when McFadden's R2 is computed.
sqrt.R2	Modified R2 with a square root penalty, only available when the Ugba & Gertheiss's R2 is computed.

Vasoconstriction and Breathing

Description

A binary data on the neural constriction of vasculature. Three test persons inhaled a certain amount of air with different rates. In some cases a vasoconstriction occurred at their skin. The objective of the study was to indicate a correlation between breathing and vasoconstriction. The test persons repeated the test 9, 8, 22 times, making a total of 39 observations.

Format

A data frame with 39 observations on the following 3 variables: - vol: amount of air - rate: rate of breathing - vaso: condition of vasculature: no vasoconstriction = 1, vasoconstriction = 2
